1. Issuance of the Tranche 2 Notes

The Board of the Company wishes to announce that an aggregate amount of S\$4,000,000 of the Tranche 2 Notes (Certificate Nos. 201 to 280) has been duly issued to the Subscriber as at 30 November 2015 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

2. Allotment and issue of Shares pursuant to the conversion of the Tranche 2 Notes

The Board wishes to announce that the Subscriber has, on 30 November 2015, exercised its rights to convert one (1) Note (Certificate No. 255) in respect of the Tranche 2 Notes. The converted Note, with an aggregate principal value of S\$50,000 will be converted into 13,888,888 Conversion Shares at the Floating Conversion Price of S\$0.0036 for each Conversion Share on 30 November 2015. An aggregate amount of S\$2,750,000 of the Tranche 2 Notes has been converted as of 30 November 2015.

The Floating Conversion Price of S\$0.0036 was determined by taking 90% of the of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notices dated, 30 November 2015.
